WAIVER, RELEASE OF LIABILITY, AND COVENANT NOT TO SUE FORM

The undersigned, acknowledge, appreciate, and agree that:

1. Player RISKS BODILY INJURY, INCLUDING PARALYSIS, DISMEMBERMENT, DISABILITY AND DEATH, AND while particular rules of the sport, skills, equipment, and personal discipline may reduce this risk, THIS RISK OF SERIOUS INJURY DOES EXIST, AS WELL AS THE RISK OF DAMAGE TO OR LOSS OF PROPERTY.
2. Parents for themselves and on behalf of Player KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERS, and assume full responsibility for Player's participation, all with respect to any activities in the Agreement.
3. If Parents observe any unusual significant hazard during Player's presence or participation in any activities in the Agreement or if Parents or Player observe any concern in Player's readiness for participation in said activity, Parents will immediately bring such to the attention of SHS Staff and remove Player from participation in the activity.
4. Parents for themselves and for Player, and on behalf of all heirs, assigns and personal representatives, HEREBY RELEASE, INDEMNIFY, HOLD HARMLESS and PROMISE NOT TO SUE SHS baseball, their members, owners, officers, officials, volunteers, employees, agents, and/or other participants, sponsors, advertisers, and, if applicable, the owners and lessors of premises used for the activity (collectively "RELEASEES"), arising directly or indirectly out of any activities set forth in the Agreement WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, and/or LOSS OR DAMAGE TO PLAYER OR PLAYER'S PROPERTY, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, EXCEPT THAT WHICH IS THE RESULT OF GROSS NEGLIGENCE OR WANTON MISCONDUCT, to the fullest extent permitted by law. As a result of the above, Parents freely and voluntarily and with knowledge thereof, waive any of my rights and those rights of Player that we may have but for the terms herein.
5. If any Court concludes that any provision or portion thereof of this agreement is invalid or unenforceable, that provision shall be severed from the remainder of the agreement so as to avoiding making the agreement invalid or unenforceable as to the remainder. All remaining provisions of this agreement shall then continue in full force. If any Court concludes that any provision is invalid in its scope, such provision shall be valid to the extent of the scope permitted by law.

I have read this Release of Liability and Waiver Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement, duress or undue influence. I am not replying on any representations by Sammamish High School related to this Release. I understand that I have the right to have my attorney review this Release before I sign it.
